

FORTIX Retailer Giveaway Contest Rules and Regulations February 4, 2015 FINAL

The FORTIX Retailer Giveaway Contest (the "Promotion") begins at 12:01 pm EST February 2nd, 2015 and ends at 11:59 EST on December 11, 2015 (the "Promotion Period"). FORTIXgiveaway.com

To enter the FORTIX Challenge, visit FortixFungicide.com/challenge to register and submit your growers' results. Results can also be mailed to FORTIX Fungicide 331 Southwest Blvd, Kansas City, MO 64108. One submission equates to 10 entries in the Promotion. A retailer can only enter a growers' results once.

To register online, visit FORTIXgiveaway.com and complete the electronic ballot. Only one online entry is eligible.

All entries must be submitted during the Promotion Period and follow the instructions to complete and submit the forms (both electronic and for the FORTIX Challenge).

Number of entries will vary per person based on entry method. One (1) entry per person through the contest website, one (1) entry per person per tradeshow and/or event during the contest period, and ten (10) entries for each grower submitted to the FORTIX Challenge Program. Any additional entries will be disqualified. Participation in the Promotion is voluntary and does not require you to purchase FORTIX Fungicide product. No illegible, incomplete, inaccurate or forged entries will be accepted and Sponsor is not responsible for lost, misrouted or stolen mail or for any computer or human error in delivery of the entries.
